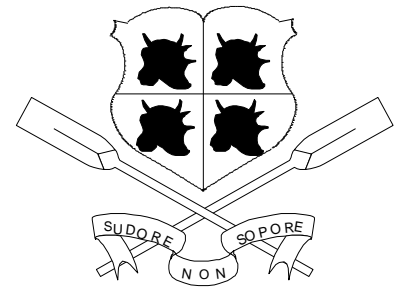

Health and Safety

Rowing and its associated training can be a strenuous activity. You should therefore be in good health and have no medical or physical condition that precludes this. Anyone who might be at risk due to a prior or existing illness or injury is advised to consult their medical practitioner prior to any exercise. Some conditions do not prevent individuals from participating in this sport, but you do have a duty to declare any condition which may put you or others at risk. Likewise you have a duty to declare any change in personal health or swimming proficiency, at any time whilst continuing to be a member of the club, which may put yourself or others at risk.
